To Whom it May Concern:

This is to certify that at a Special Town Meeting convened on Saturday, November 19, 1983 at 7:00pm at the Gay Head Town Hall, a quorum of voters assembled did approve the following articles:

ARTICLE 14: To see if the Town will vote to authorize the Selectmen to sign the settlement agreement known as the "Joint Memorandum of Understanding Concerning Settlement of Gay Head, Massachusetts Indian Land Claim" which shall have been approved by the Wampanoag Tribal Council of Gay Head, Inc. and the Gay Head Taxpayers Association at the time of said Special Town Meeting, which agreement, when fully implemented according to its terms, will result in the withdrawl of the pending law suit against the Town of Gay Head known as "Wampanoag Tribal Council of Gay Head, Inc. vo. Town of Gay Head et al".

ARTICLE 14: The article was read, and having been motioned to the floor previously by the Finance Committee, the Moderator asked for discussion of the article. Discussion concluded, the vote was recorded as follows:

AYES: 92 NOS: 13

Article 14 therefore carried as read.

ARTICLE 15: To see if the Town will vote to petition the General Court of the Commonwealth of Massachusetts for the passage of legislation authorizing the Town to transfer title to certain Town owned lands to the Wampanoag Tribal Council of Gay Head, Inc., and to authorize additional provisions necessary to implement the settlement agreement referred to in Article 14 of this warrant as set forth in draft legislation known as "an Act to Implement the Settlement of the Gay Head Indian Land Claims".

ARTICLE 15: The article vas read. It had been previously motioned to the floor by the Finance Committee. A motion was made to amend the article as follows: "To amend Article 15 by inserting the following phrase after the words Wampanoag Tribal Council of Gay Head, Inc......'or a land corporation created by the Wampanoag Tribal Council of Gay Head, lac.'"etc..... The amended article then read as follows:

ARTICLE 15: To see if the Town will vote to petition the General Court of the Commonwealth of Massachusetts for the passage of legislation authorizing the Town to transfer title to certain Town owned lands to the Wampanoag. Tribal Council of Gay Read, Inc., or a tribal land corporation created by the Wampanoag Tribal Council of Gay Head, Inc., and to authorize additional provisions necessary to implement the settlement agreement referred to in Article 14 of this warrant as set forth in draft legislation known as "an Act to Implement the Settlement of the Gay Head Indian Land Claims".

The amendment was accepted as read. Then the vote on the amended article was as follows:
